





# WOULD YOU STAKE YOUR LIFE ON IT?

In the hours and days immediately following a hurricane, the top priorities for first responders and emergency personnel will be search and rescue and law enforcement. It's your personal responsibility to provide the first line of defense for your family.

## **ASK YOURSELF:**

- Is your family prepared to be on its own for 3 days or more?
- Do you have enough food, water and other critical supplies for your entire family to last at least 3 days?

Once at www.FloridaDisaster.org, you will be asked to provide information about your home, your family, and pets. Using this information, the website will create a personalized Family Disaster Plan that you can print and save for future emergencies.

#### Included in your plan will be:

- Recommended amounts of food and water based on the size of your family.
- Contact information for your local emergency responders and maps of your local Evacuation Zones.
- Checklists of important steps to take before, during, and after a disaster.

# Your Family Disaster Plan will also include detailed instructions on creating a disaster supply kit for your family.

#### This kit should include:

At least three days worth of drinking water and non-perishable food for your entire family.

#### Opportunities in the Affordable Care Act for Enhancing Services for Our Children and Adult Family Members with Behavioral Health Needs and Developmental Disabilities

The enactment of the Patient Protection and Affordable Care Act in March 2010 has ushered in a multi-year process to reform health care delivery in the United States. The Act contains many provisions that can improve services and supports for children and adults with behavioral health needs and developmental disabilities. States will have the central roles in shaping the opportunities and deciding the comprehensiveness of care available for individuals with disabilities. The Act provides mechanisms for families who have never had health insurance to obtain affordable coverage and modifies many programs, such as Medicaid and CHIP, which currently provide many services for individuals with disabilities. At the same time, there is much controversy surrounding the Act that will likely affect what is put into place. The timeline for implementing the Act is moving quickly and most states are already designing and planning for the options they will put in place. States face many challenges in implementing the new legislation, but the solutions to these challenges also offer opportunities to improve services for individuals with disabilities. It is critically important for family members, advocates and service providers to share their voices and help direct the decisions that will be made.





Jim Wotring and Gary Macbeth from the Georgetown University National Technical Assistance Center for Children's Mental Health will discuss health care reform with emphasis on:

- An overview of major provisions in the Affordable Care Act that provide particular opportunities for improving services for children and adult family members with disabilities;



#### Autism: Unique Biomarkers and Novel Treatment Approaches

Autism Spectrum Disorders (ASD) are neurodevelopmental disorders characterized by deficits in social interactions, stereotypic behaviors, and learning. There are still a few insights for its early detection or treatment. The presence of brain expression of pro-inflammatory cytokines and circulating auto-antibodies against brain proteins indicate immune dysfunction. Many ASD children suffer from "allergic-like" problems in response to environmental triggers that could contribute to brain inflammation at least in a subgroup of ASD patients. We recently identified high levels of the serum neuropeptide neurotensin and mitochondrial DNA in young children with autism. These molecules could serve as unique biomarkers as well as targets for novel treatments.

## Scaling the Heights with Steve Wampler

In September 2010, Steve Wampler became the first person with Cerebral Palsy to climb Yosemite's El Capitan Mountain - widely considered one of the greatest challenges in all of rock climbing. Steve was born with a severe form of Cerebral Palsy and uses an electric wheelchair for mobility; however, he has never let this stop him from living a full life. His parents helped build this foundation from an early age, by encouraging him to do things just like any other kid. He also attended a regular summer camp a few hours' drive from his parents' Northern California home, which helped continue to round him out as a person. Steve went on to attend and graduate from the University of California at Davis with a degree in

Environmental Engineering. After graduation, Steve took a job with Raychem and moved to San Diego, where he would meet and marry Elizabeth Daniel. After a few years of working together, Steve and Elizabeth decided to branch out and become entrepreneurs, starting The Convention Company to help assist meeting and convention planners across the nation. However, in 2002, the Wamplers learned that the camp Steve attended as a child had closed due to a lack of funding. Collectively, the Wamplers decided to start the Stephen J. Wampler Foundation to help re-open the camp, and sponsor the same outdoor wilderness program for physically disabled children regardless of a family's ability to pay. Today, Steve and Elizabeth and their two children continue their work to inspire every family and every child with a disability to dream of everything they would in life, just as if they had no disability at all.


