The Agency for Persons with Disabilities (APD) annually serves more than 55,000 Floridians with developmental disabilities as defined in Florida Statutes, Chapter 393. This includes individuals with severe forms of autism, cerebral palsy, spina bifida, intellectual disabilities, Down syndrome, Phelan-McDermid syndrome, Prader-Willi syndrome, and children aged 3-5 who are at a high risk of a developmental disability.

APD works in partnership with local communities and private providers to support individuals with developmental disabilities in living, learning, and working in their communities. The agency also educates the public on disability issues, supports efforts to increase the number of individuals with developmental disabilities in the workforce, and helps identify the needs of people with developmental disabilities for supports and services.

The agency is governed by Chapter 20, Chapter 393, and Chapter 916 of the Florida Statutes. APD is headquartered in Tallahassee, with six regional offices working directly with customers and service providers, plus two developmental disabilities centers and one forensic center.

Ann's Angels AWF Inc is a public nonprofit and donations are always tax deductible.

Ann's Angels also trains other programs to do the same kind of programs in their area and has done so since our UCanSki2 days. We look forward to continuing this into the future as well as our Advanced Waterski programs and competition training for those that want more.

Instead of wheels, the chair utilizes rubber tracks, allowing the user off path mobility without the fear of getting stuck.

Now adults and children with physical disabilities or limitations can independently traverse over uneven ground, deep sand, mud, gravel, and rough terrain. The Trackchair creates opportunities to participate in outdoor recreation and leisure activities. Imagine roaming down the beach, listening to the waves crash while shark tooth hunting with your friends. Or maybe going sight-seeing through nature during a family outing at the park. Hiking trails? No problem. There are endless possibilities.

Bird Dog Boats of Florida, Inc. is a 501(c)3 nonprofit organization providing adaptive boating for people using wheelchairs or having other accessibility requirements. Operating throughout Florida, BDB partners with many organizations to provide group events and private boat charters. In 2015, an adaptive boat was designed for this program with the engine well located in front of the helm so a person using a manual wheelchair, power wheelchair, or trackchair could easily roll onto the back of the boat for a nice day of boating or fishing.

Thanks to the efforts and support from Florida Disabled Outdoors Association, Bird Dog Boats has now safely completed over one hundred voyages with people using wheelchairs. In April of 2019, BDB was awarded the Leisure for Life Award from Florida Disabled Outdoors Association. In November of 2019, BDB was awarded a grant to serve veterans through Florida Disabled Outdoors Association, Disabled Sports USA, Bob Woodruff Foundation and the National Football League.

Now more than ever, boating is recognized as an important outdoor activity that serves small groups of families or friends in a semi-secluded setting. Buddy Bike is the alternative tandem bicycle for riders with special needs providing adaptive and therapeutic cycling and educational opportunities for riders with autism, down syndrome, sight impairment, balance issues, low muscle tone and other disabilities that would prevent them from riding a bike safely on their own. The Buddy Bike places the stoker (smaller rider) in the front seat while the rear rider controls the steering. The Buddy Bike has a lower front seat so both riders can safely enjoy the view. It is shorter in length than a typical tandem, making it easier to store and transport.

The Buddy Bike is CPSC safety-rated for up to 380 pounds, making it the ultimate family bike that can be enjoyed by riders of most ages and abilities. Many families obtain funding to purchase the Buddy Bike as therapeutic equipment.

We are now offering adaptive and alternative bicycles for riders of all ages, sizes and abilities, including adult trikes, walking trikes, recumbent trikes and hand cycles. CARD, which stands for the Center for Autism and Related Disabilities, is a statewide network of seven university-based outreach and support centers throughout Florida, located at Florida State University, the University of Central Florida, the University of Florida at Gainesville, the University of Florida Health Science Center at Jacksonville, the University of South Florida, Florida Atlantic University and the University of Miami & Nova Southeastern University (UM-NSU CARD).

CARD's mission is to optimize the potential of people living with autism and related disabilities by providing support services to them, their families, and the professionals who work with them. The Centers are funded by the Florida Legislature through the Florida Department of Education, and all services are provided free of charge. CARD services are designed to build on the capacities of state and local resources, not to duplicate or replace them.

Some of the services that CARD provides include: Individualized Client and Family Support, Family and Professional Training, Public Education and Awareness and Community Outreach, and Programmatic Consultation and Technical Assistance. The Centers have been providing services and supports at no charge to individuals with autism spectrum disorders and their families for 27 years. CARD is the largest state-wide model program for autism supports in the United States, and is now being replicated in other states across the nation.

CECO's mission is to transform the lives of children and adults with neurological motor disabilities so that they may achieve their greatest level of independence through conductive education, integrating physical, cognitive, and social skills.

The Conductive Education Center of Orlando was founded by a local family in Winter Park, whose son was born three months premature with cerebral palsy and other complications. Just before his fourth birthday, his parents learned about a program in Budapest, Hungary called Conductive Education.

This program was making it possible for children with motor disabilities to move and progress beyond the expectations of doctors, producing outcomes that exceeded what was believed to be possible. That summer, they held a 6-week pilot program with five children in Winter Park, Florida. As the weeks progressed, parents saw dramatic changes in their children, and they made a lifelong commitment to helping children with motor disabilities reach their full potential by founding The Conductive Education Center of Orlando (CECO).

Since our inception in 2001, CECO has served many individuals with neurological motor disabilities. With the help of a dedicated board, our CECO families, and the staff and supporters we call our family, CECO has grown tremendously. Expanding from the first pilot program of five individuals, we now house eight diverse programs serving the needs of students of all ages.

We are a 501(c)(3) not-for-profit corporation that has authority and responsibility under nine federal grants. We are obligated to defend the Americans with Disabilities Act (ADA), the nation's strongest law protecting the civil rights of people with disabilities. DRF assists people with disabilities to solve disability-related problems. We will provide you with the necessary tools and information to advocate for your rights. However, certain issues may require our legal assistance. We are here to help you with:

- Abuse, neglect, or rights violations for individuals who live in institutional and residential settings;
- Community placement;
- Access to publicly-funded benefits and services, particularly home and community-based services;
- Self-empowerment and rights of individuals to gain greater control over important life decisions;
- Control over use of public benefits and personal assets;
- Equal access to public and private programs and services, including businesses, transportation, post-secondary education, housing, and assistive technology;
- Access to vocational rehabilitation and blind services;
- Access to a free and appropriate public education in the most inclusive environment;
- Least restrictive alternatives to guardianship; and
- Voting rights and civic participation.

FAAST (The Florida Alliance for Assistive Services & Technology) is the state of Florida's assistive technology program. FAAST is administered through the Florida Department of Education, Division of Vocational Rehabilitation. AT FAAST, our goal is to serve people with a varying range of abilities by providing information and assistance related to Assistive Technology (AT).

What is Assistive Technology? Assistive Technology (AT) is any device, gadget, hardware or software used by a person to do things for themselves that might otherwise be difficult or impossible to do because of their disability. Assistive Technology helps people with a wide range of abilities to live, work, learn, and play as independently as possible.

Activities provided by FAAST include device loans through our Lending Library, device demonstrations to compare features of different devices within a category, device recycling, refurbishment, & reutilization, a low-interest financing program to purchase AT, varied trainings on AT products, services, and other disability-related topics, and most importantly, information and assistance through our statewide help desk.

Through one of our 11 locations around the state, FAAST happily serves all Floridians, including users of Assistive Technology, family members, service providers, educators, therapists, employers, health and rehabilitation professionals, AT vendors, procurement officials, and all other interested parties throughout the state of Florida. #### **Family Care Councils Florida**

In 1993, the Florida Legislature passed legislation (Florida Statutes 393.502) establishing an all-volunteer Family Care Council (FCC) to be located within each service area of the Agency for Persons with Disabilities (APD). Each of the 15 FCCs is made up of Governor-appointed individuals with developmental disabilities who qualify for services from APD and the parents, siblings, grandparents, and guardians of individuals who have developmental disabilities. In addition, many councils receive vital support from interested individuals in their local communities.

APD has the responsibility for the health and safety of individuals with developmental disabilities. APD supports individuals with developmental disabilities and their families by helping them identify needs and funding to purchase supports and services. The purpose of each FCC is to advise APD, develop a plan for the delivery of family support services, and monitor the implementation and effectiveness of the services and supports provided under the plan. The functions of the FCCs are to provide education and outreach to families, to review and make recommendations as to the effectiveness of the delivery of supports and services and to share information with other Family Care Councils. Each FCC represents a geographic area and works closely with the regional APD office to help families receiving services.

The FCC also works closely with other local disability organizations and programs to access services and opportunities for individuals with developmental disabilities and their families who may be on the APD Waiting List.

The Florida Diagnostic and Learning Resources System (FDLRS) is a discretionary project of the Florida Department of Education (FLDOE) Bureau of Exceptional Education and Student Services (BEESS). BEESS directly supports the FLDOE's Guiding Principles and Strategic Initiatives.

The FDLRS Associate Centers provide an array of instructional and technical support services to school district Exceptional Student Education programs statewide. The four central functions of each FDLRS Associate Center are Child Find, Parent Services, Human Resource Development, and Technology. FDLRS includes 19 Associate Centers that serve Florida's sixty-seven school districts. These centers collaborate with districts, agency and support personnel, communities, families, and other educational personnel providing support services for educators, parents, school administrators, and students with exceptionalities. Funding also supports implementation of the Professional Development Alternatives (PDA).

PDA online modules are designed to provide Florida teachers with widely available, easily accessible opportunities to increase their skills in the area of exceptional student education. In support of sustaining highly qualified educators, the Statewide Elementary K-6 and the Middle Grades 5-9 Online Content Review Modules are also coordinated through the FDLRS Network.

There is training to assist individuals who are blind or visually impaired, as long as their vison is poor in both eyes even with glasses or contact lenses. DBS has 16 offices throughout the State of Florida.

Programs and services include Blind Babies; Children's Program; Transition Program and Pre Employment Transition Services; Vocational Rehabilitation; Business Enterprise program; Independent Living Services; The Rehabilitation Center for the Blind and The Braille Talking Books Library. DBS also offers Employer Services. Qualified personnel work with potential employers to demonstrate how someone who is blind or visually impaired can perform the required job duties. This may include onsite visits to determine assistive tools and devices.

The Florida Department of Education works hand in hand every day with parents, teachers, educators and community members to improve Florida's education system for students of all backgrounds and abilities. The department's Bureau of Exceptional Education and Student Services (BEESS) administers programs for students with disabilities as well as coordinates student services throughout the state and participates in multiple inter-agency efforts designed to strengthen the quality and variety of services available to students with special needs.

The bureau resource and information center (BRIC) provides parents, educators, and other Floridians with access to information about exceptional student education, student services, juvenile justice education, early intervention, parent and professional partnerships, and many other topics.

BEESS has over 100 discretionary projects that provide trainings, services, information and resources to parents, educators, school districts and other Floridians.

Each year BEESS parent services surveys parents of children with an individual educational plan (IEP) to determine how well their child's school is partnering with them and promoting their involvement in their child's education. All states must collect this data as part of their State Performance Plan, as required under the Individuals with Disabilities Education Act (IDEA). BEESS uses this parent input for their annual work plan to provide schools and districts guidance on the areas of need.

Signed into law by Florida's governor on January 23, 2016, the Florida Postsecondary Comprehensive Transition Program Act (the Act) (FS 1004.6495) established the Florida Center for Students with Unique Abilities at the University of Central Florida (the Center) and charged the Center with managing the Florida Postsecondary Comprehensive Transition Program (FPCTP) application and approval process.

The Act also established criteria for FPCTP approval, scholarship awards for eligible students to attend approved programs, grant awards to promote new program development and existing program enhancements, and accountability requirements associated with these opportunities.

The purpose of the Act is to "increase independent living, inclusive and experiential postsecondary education, and employment opportunities for students with intellectual disabilities through degree, certificate, or nondegree programs and to establish statewide coordination of the dissemination of information regarding programs and services for students with disabilities.

The intent of the Legislature that students with intellectual disabilities and students with disabilities have access to meaningful postsecondary education credentials and be afforded the opportunity to have a meaningful campus experience." (FS §1004.6495(2)) The Center is working with higher education institutions across Florida to support implementation of the Act in three primary ways:

- (a) facilitate application and approval of their program that serves students with intellectual disabilities as a FPCTP,
- (b) provide scholarship awards to students attending an institution's approved FPCTP, and
- (c) provide grant funding to foster starting up new and/or enhancing existing programs.

These three components of the Center's work aim directly at achieving the purpose of the Act.

Florida KidCare is the state of Florida's high quality, low-cost health and dental insurance program for children from birth through the end of age 18. Florida KidCare is made up of four programs: Medicaid for Children, MediKids, Florida Healthy Kids, and the Children's Medical Services (CMS) Managed Care Plan. Every child is different and so are their medical needs.

Florida KidCare ensures that all children have the coverage they need through each stage of their growth and development. This includes a wide range of benefits and services, such as doctor visits, prescriptions, hospital stays, mental health services, immunizations, checkups, vision and hearing screenings and dental care.

Most Florida KidCare families pay only \$15 or \$20 a month for insurance coverage, but many pay nothing at all. Full-pay options are available for those families who do not qualify for subsidized coverage. Eligibility in the program is based on a child's age, family size and household income. An Eligibility Calculator tool available on the Florida KidCare website can help families estimate their monthly premium in 15 seconds or less by answering two simple questions. The results can be emailed to the family for future reference.



Step Up For Students is a nonprofit scholarship funding organization that helps administer five programs for Florida schoolchildren.

The Gardiner Scholarship helps Florida families customize education for their children with certain special needs who are ages 3 through 22. The scholarship covers 17 diagnoses, including autism spectrum disorder, Down syndrome, intellectual disability, spina bifida and traumatic brain injury. Parents can use scholarship money toward a combination of approved programs and providers that best meet their children's unique learning needs. These include schools, therapists, curriculum, technology – even a college savings account.

Two scholarships are available for lower-income students, the Florida Tax Credit Scholarship and Family Empowerment Scholarship. Both scholarships give students an option to find the best schools to meet their K-12 learning needs.

The Hope Scholarship Program provides relief to students bullied in public schools. It gives them an opportunity to transfer to a K-12 public school with capacity in another district or to request a scholarship for the student to attend an eligible private school.

The Reading Scholarship Accounts program is an education savings account for third-through fifth-grade students enrolled in public schools who struggle with reading. Worth \$500 each, these educational savings accounts help parents access approved programs and providers to help their children improve their reading skills. Program funds are limited and are available on a first-come, first-served basis.

Although Tiffany is no longer with us, the dream we shared together is becoming a reality in the form of Tiff's Place, soon to be an American home-away-from-home for those with neuromuscular disease and other similar conditions, as well as wounded veterans and their families.

All these underserved members of our society are welcome to vacation with us free from worry about adequate accommodations or other logistical concerns.




## The Squeaky Wheelchair – Living a Full and Meaningful Life Despite a Disability




## Paloma's Dream: The True Story of One Girl's Mission to Help Kids, Inspire Activism, and Survive Middle School


#### Fixing BooBoo: A story of traumatic brain injury





# ADVOCACY EQUALITY DIGNITY

Disability Rights Florida assists people with disabilities to solve disability-related problems. We will provide you with the necessary tools and information to advocate for your rights. However, certain issues may require our legal assistance. We are here to help you with:

- Disputes involving Medicaid, SSDI, and SSI eligibility;
- Discrimination in housing, architectural barriers, effective and accessible communication, service animals, employment, vocational rehabilitation, and access to programs and services;
- Abuse, neglect, and rights violations in an institution, prison or jail;
- Access to mental health and support services that provide individualized treatment;

- Rights to a least restrictive environment, community integration, privacy, choice, dignity, and other rights;
- Barriers to a free and appropriate education, K-12 special education, transition services, and post-secondary education;
- Investigation of stolen or misused funds, exploitation, or neglect by representative payees;
- Voting registration, vote casting, and accessible polling places;
- Access to assistive technology;
- Supported Decision-Making as an alternative to guardianship.
